 - c. The “Setting” fails to pay any statutory fee for which it is properly charged as part of the “Award” Approval and Monitoring process.

Schedule 1

Health & Safety Risk Assessment.

The Health & Safety Risk Assessment must be up to date and available for inspection at any time.

Schedule 2

First Aid Risk Assessment.

The First Aid Risk Assessment must be up to date and available for inspection at any time.

Schedule 3

A First Aid Emergency Procedure Guide.

The First Aid Emergency Procedure Guide must be up to date and available for inspection at any time.

Schedule 4

Number of Trained Paediatric First Aiders.

In order to achieve the "In Safe Hands Award" the Setting must have:

- (a) A Minimum of 35% of its Staff (working with Children) with a current Paediatric First Aid Certificate (12 hours) and;
- (b) A Minimum of 35% of its Staff (working with children) with a current Emergency Paediatric Certificate.

The minimum as required by The Statutory Framework for the Early Years Foundation Stage. (effective 3 April 2017) is:

The "Setting" must have at least one person who has a current Paediatric First Aid certificate (12 hours) and must be on the premises and available at all times when children are present and must accompany children on outings.

Schedule 5

Disclosure and Barring Service (DBS) checks.

Every Member of Staff in the "Setting" must have a DBS certificate.

Schedule 6

Renewal of Approval Certificate

The "Setting" must confirm in writing that all the original assessment processes and procedures are still in place **(Schedules 1-5)**.

Schedule 6a

Twelve Monthly Updates.

The "Setting" must complete a 12 monthly update in relation to the Trained Paediatric First Aid staff and signed by the OFSTED registered person within the setting. Failure to do so will result in suspension of the "Setting" and removal from the FAIB database.

Schedule 7

Childminders.

A Childminder and any Assistant who might be in sole charge of Children for any period of time **MUST** hold a current Paediatric First Aid Certificate (12 hour).

Schedule 8

Content of Paediatric First Aid (12 Hour) (Face to Face or Blended).

Cover theoretical and practical training in any new First Aid methods and procedures and include all of the following subjects:

- (a) Be able to assess an Emergency situation and prioritise what action to take.
- (b) Help a baby or child who is unresponsive and breathing normally.
- (c) Help a baby or child who is unresponsive and NOT breathing normally.

(d) Help a baby or child who is having a seizure.

(e) Help a baby or child who is choking.

(f) Help a baby or child who is bleeding.

(g) Help a baby or child who is suffering from shock caused by severe blood loss (hypovolemic shock).

(h) Help a baby or child who is suffering from anaphylactic shock.

(i) Help a baby or child who is suffering from electric shock.

(j) Help a baby or child who has burns or scalds.

(k) Help a baby or child who has a suspected fracture.

(l) Help a baby or child with head, neck or back injuries.

(m) Help a baby or child who is suspected of being poisoned.

(n) Help a baby or child with a foreign body in eyes, ears or nose.

(o) Help a baby or child with an eye injury.

(p) Help a baby or child with a bite or sting.

(q) Help a baby or child who is suffering from the effects of heat or cold.

(r) Help a baby or child with a diabetic emergency, asthma attack, allergic reaction, meningitis and febrile convulsions.

(s) Understand the role and responsibilities of the paediatric first aider (including appropriate contents of a first aid box and recording accidents and incidents).

Content of Emergency Paediatric First Aid (6 Hour) (Face to Face).

Cover theoretical and practical training in any new First Aid methods and procedures and include all of the following subjects:

- (a) Be able to assess an Emergency situation and prioritise what action to take.
- (b) Help a baby or child who is unresponsive and breathing normally.
- (c) Help a baby or child who is unresponsive and NOT breathing normally.
- (d) Help a baby or child who is having a seizure.
- (e) Help a baby or child who is choking.
- (f) Help a baby or child who is bleeding.
- (g) Help a baby or child who is suffering from shock caused by severe blood loss (hypovolemic shock).
